RESOLUTION NO. 055 s. 2025

A RESOLUTION RECOMMENDING AWARD TO MICROGENESIS BUSINESS CENTER AND COMPUTRON BUSINESS CENTER FOR THE PROCUREMENT OF DESKTOP COMPUTER FOR VARIOUS OFFICES THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT

WHEREAS, the Office Management Information System/Electronic Data Processing intends to procure Desktop Computer with an Approved Budget for the Contract (ABC) of three Million Nine Hundred Thirteen Thousand Pesos Only (PhP 3,913,000.00);

WHEREAS, the Bids and Awards Committee (BAC) declared the first bidding as FAILED under BAC Resolution No. 366 dated July 19, 2024;

WHEREAS, the BAC declared the second bidding as FAILED under BAC Resolution No. 477 s. 2024 dated September 10, 2024;

WHEREAS, on October 17, 2024 a Request for Quotation (RFQ) for the said project was posted on the website of the Philippine Government Electronic Procurement System (PhilGEPs), the ISAT U Website and a conspicuous place within the premises of the university in accordance with Section 21.2 of the RA 9184;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

1. Microgenesis Business Systems
2. Computron Business Center
3. Terabit Computer Systems Corporation

WHEREAS, two (2) bidders submitted a quotation within the deadline set on October 23, 2024 at 5pm, namely;

1. Microgenesis Business Systems
2. Computron Business Center

WHEREAS, the received quotations were evaluated by the Committee on a 'per line item' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Microgenesis Business Systems amounting to Three Million Two Hundred Fifty Six Thousand Two Hundred Pesos Only (3,256,200) and Computron Business Center amounting to Two Million One Hundred Seventy One Thousand Four Hundred Seventy Pesos Only (2,171,470.00) was found to be within the ABC;

WHEREAS, upon evaluation of the Technical Working Group (TWG), Microgenesis compliant on the items no. 1,4,5,6 and 7 and Computron Business Center compliant on the items no. 2 and 3 as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of Two Million Eight Hundred Sixty Eight Thousand Seven Hundred Pesos Only (PhP 2,868,700.00) to Microgenesis Business Center and Two Hundred Forty Four Pesos Thousand Five Hundred Pesos Only (PhP 244,500.00) to Computron Business Center through an Alternative Method Of Procurement -Negotiated Procurement (Two Failed Biddings); and

- b. To recommend for approval of the University President the foregoing findings.
