A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE INSTALLATION OF CANOPY AT 3RD FLOOR BALCONY (N-BUILDING) Project Reference No. ISAT U INFRA 2024-02-004

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the INSTALLATION OF CANOPY AT 3RD FLOOR BALCONY (N-BUILDING) on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Seven Hundred Three Thousand One Hundred Eighty One Pesos and Six Centavos Only (PhP 703,181.06) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on February 15, 2024 with two (2) prospective bidders in attendance, namely;

- 1. Hortinela Construction and Supply
- 2. NGP Construction

WHEREAS, in response to the said posting, four (4) prospective bidders purchased the bidding documents and submitted their proposal within the deadline set on February 26, 2024 at 5pm, namely;

- 1. Hortinela Construction and Supply
- 2. NGP Construction
- 3. Edison C. Builders and Construction Supply
- 4. Giantwest Construction

WHEREAS, during the bid opening held last February 27, 2024, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

To declare that HORTINELA CONSTRUCTION AND SUPPLY as the Lowest Calculated and Responsive Bid (LCRB) for the INSTALLATION OF CANOPY AT 3RD FLOOR BALCONY (N-BUILDING) and awarded the contract in the total amount of Six Hundred Thirty Four Thousand Nine Hundred Sixty Four Pesos and Forty Three Pesos Only (Php 634,964.43) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
