RESOLUTION NO. 180 s. 2025

A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO D' X-MEN BUILDERS CORPORATION FOR THE CONSTRUCTION OF UNIVERSITY LANGUAGE CENTER Project Reference No. ISAT U INFRA 2025-01-003

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the CONSTRUCTION OF UNIVERSITY LANGUAGE CENTER on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Five Hundred Thousand Pesos Only (PhP 1,500,000.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on February 12, 2025 with Five (5) prospective bidders in attendance, namely;

- 1. N. Javellana Construction Services
- 2. D' X-Men Builders Corporation
- 3. Quatro Amigos Builders and Supply
- 4. Namco Construction
- 5. Urbancon Builders and Supply

WHEREAS, during the scheduled date for the selling of Bid Documents on February 12-21, 2025, Four (4) interested bidders availed the official bidding documents in the amount of Five Thousand Pesos Only (PhP 5,000.00), namely;

- 1. Cidclyde Builders and Constrution Supply
- 2. D' X-Men Builders Corporation
- 3. Quatro Amigos Builders and Supply
- 4. Namco Construction

WHEREAS, Four (4) bidders submitted a bid proposal within the deadline set on February 22, 2025 at 5pm, namely;

- 1. Cidclyde Builders and Constrution Supply
- 2. D' X-Men Builders Corporation
- 3. Quatro Amigos Builders and Supply
- 4. Namco Construction

WHEREAS, during the bid opening held last February 24, 2025, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidder using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that D' X-MEN BUILDERS CORPORATION as the Lowest Calculated and Responsive Bid (LCRB) for the CONSTRUCTION OF UNIVERSITY LANGUAGE CENTER and awarded the contract in the total amount of One Million Two Hundred Thirty Five Thousand Six hundred Ninety Pesos and Five Centavos Only (PhP 1,235,690.05) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
