# A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO GIANTWEST CONSTRUCTION CORPORATION FOR THE CONVERSION OF JALOUISE TO GLASS PANEL ALUMINUM FRAME WINDOW AT 2<sup>ND</sup> FLOOR TEACHER EDUCATION BUILDING-PDAS

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the CONVERSION OF JALOUISE TO GLASS PANEL ALUMINUM FRAME WINDOW AT 2<sup>ND</sup> FLOOR TEACHER EDUCATION BUILDING -PDAS on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Two Hundred Twenty Seven Thousand One Hundred Eighty Seven Pesos and Fifty Centavos Only (PhP 1,227,187.50) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on May 14, 2024 with five (5) prospective bidders in attendance, namely;

- 5. JGC Construction

WHEREAS, in response to the said posting, five (5) prospective bidders purchased the bidding documents and submitted their proposal within the deadline set on May 25, 2024 at 5pm, namely;

- 2. Conquest Construction Services
- Akia J Construction and Supplies, Inc.
- 4. Oting Construction and Supply
- 5. Quatro Amigos Builders & Supply

WHEREAS, during the bid opening held last May 27, 2024, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;
