WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF OTHER SUPPLIES AND MATERIALS FOR VARIOUS OFFICES on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Eight Hundred Thirty Six Thousand Six Hundred Pesos Only (PhP 836,600.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on June 21, 2024 with one (1) prospective bidder in attendance, namely;

WHEREAS, during the scheduled date for the selling of Bid Documents on June 26, 2024 - July 1, 2024, Two (2) interested bidders availed the official bidding documents in the amount of One Thousand Pesos Only (PhP 1,000.00), namely;

WHEREAS, Two (2) bidders submitted a bid proposal within the deadline set on July 2, 2024 at 5pm, namely;
