A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO COMPUTRON BUSINESS CENTER FOR THE PROCUREMENT OF IT EQUIPMENT AND SUPPLIES FOR VARIOUS OFFICES

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF IT EQUIPMENT AND SUPPLIES FOR VARIOUS OFFICES on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Eight Hundred Fifty Five Thousand Six Hundred Pesos Only (PhP 1,855,600.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on June 21, 2024 with three (3) prospective bidders in attendance, namely;

1. Computron Business Center
2. AEP Integration Systems, Inc.
3. Microgenesis Business Systems

WHEREAS, during the scheduled date for the selling of Bid Documents on June 26, 2024 - July 1, 2024, Three (3) interested bidders availed the official bidding documents in the amount of Two Thousand Pesos Only (PhP 2,000.00), namely;

1. Copywise Imaging Supplies
2. Computron Business Center
3. Oxord Computer Solutions and Repair Center

WHEREAS, Three (3) bidders submitted a bid proposal within the deadline set on July 2, 2024 at 5pm, namely;

1. Copywise Imaging Supplies
2. Computron Business Center
3. Oxord Computer Solutions and Repair Center

WHEREAS, during the bid opening held last July 3, 2024, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that COMPUTRON BUSINESS CENTER as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF IT EQUIPMENT AND SUPPLIES FOR VARIOUS OFFICES and awarded the contract in the total amount of One Million Five Hundred Twenty Six Thousand Five Hundred Eighty Five Pesos Only (Php 1,526,585.00) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
