# A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PHILIPPINE DUPLICATORS, INC. FOR THE PROCUREMENT OF IT EQUIPMENT AND SUPPLIES FOR VARIOUS OFFICES (LOT 2) Project Reference No. ISAT U GOODS 2024-08-070

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF IT EQUIPMENT AND SUPPLIES FOR VARIOUS OFFICES on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Two Million Four Hundred Eighty Nine Thousand Five Hundred Pesos Only (PhP 2,489,500.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on August 28, 2024 with four (4) prospective bidders in attendance, namely;

- 1. Computron Business Center
- 2. Philippine Duplicators, Inc.
- 3. Microgenesis Business Systems (Via Google Meet)

WHEREAS, during the scheduled date for the selling of Bid Documents on September 3-7, 2024, One (1) interested bidder availed the official bidding documents in the amount of Three Thousand Pesos Only (PhP 3,000.00), namely;

WHEREAS, one (1) bidder submitted a bid proposal within the deadline set on September 9, 2024 at 5pm, namely;
