**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID
(LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF IT
EQUIPMENT FOR RESEARCH

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT IT EQUIPMENT FOR RESEARCH on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of Four Hundred Ten Thousand Pesos Only (PhP 410,000.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on September 20, 2023 with three (3) prospective bidders in attendance, namely;

2. AEP Systems Integrations, Inc.
3. Coccyx Computer Sales and Service

WHEREAS, in response to the said posting, there were three (3) prospective bidders purchased the bidding documents, namely;

1. Computron Business Center
2. Circle Compubiz
3. Oxord Computer Solutions and Repair Center

WHEREAS, there were three (3) the prospective bidders who submitted their bid proposals within the deadline set on October 3, 2023 at 5pm, namely;

4. Computron Business Center
5. Circle Compubiz
6. Oxord Computer Solutions and Repair Center

WHEREAS, during the bid opening held last October 4, 2023, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

To declare that COMPUTRON BUSINESS CENTER, as the Lowest Calculated and Responsive Bid (LCRB) for the PROCUREMENT IT EQUIPMENT FOR RESEARCH and awarded the contract in the total amount of Two Hundred Ninety Seven Thousand Five Hundred Sixty Pesos Only. (Php297,560.00) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.


