**RESOLUTION NO. 695, s. 2023**

**A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF FURNITURE AND FIXTURES FOR PICO**

**Project Reference No. ISAT U GOODS 2023-08-074**

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF FURNITURE AND FIXTURES FOR PICO on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) Three Hundred Forty One Thousand Pesos Only (Php 341,000.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on September 20, 2023 with no prospective bidders in attendance and no prospective bidders purchased the bidding documents;

WHEREAS, there is no prospective bidder who submitted their bid proposals within the deadline set on at 5pm;

WHEREAS, during the bid opening held last October 4, 2023, no bidder submitted their bid and the BAC declared the first bidding as "failed" under BAC Resolution No. 694 citing a Section 35.1.a of the Revised IRR of RA 9184 provides that " *The BAC shall declare a failure of bidding when no bids are received*";

WHEREAS, on October 8, 2023, the Bids and Awards Committee (BAC) posted a second Invitation to Bid for the PROCUREMENT OF FURNITURE AND FIXTURES FOR PICO on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University in accordance with Section 21.2. of the IRR of RA9184;

WHEREAS, a Pre-Bid Conference was held on October 16, 2023 and one (1) prospective bidder was in attendance, namely Progress Home and Office Furnishings;

WHEREAS, in response to the said posting, only Progress Home and Office Furnishings were the prospective bidder that purchased the bidding documents and submitted its bid proposal within the deadline set on October 26, 2023 at 5pm;

WHEREAS, during the bid opening held last October 27, 2023, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidders using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

WHEREAS, the BAC has conducted post-qualification to Progress Home and Office Furnishings last June 15 2023 for the project similar to this project and determined that the bidder concerned has complied with and is responsive on all requirements and conditions as specified in the Bidding Documents;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that PROGRESS HOME AND OFFICE FURNISHINGS , as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF FURNITURE AND FIXTURES FOR PICO and awarded the contract in the total amount of Two Hundred Eighty Seven Thousand Five Hundred Pesos Only (Php 287,500.00) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
