A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF MINI BUS FOR UNIVERSITY Project Reference No. ISAT U GOODS 2023-06-068

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF MINI BUS FOR UNIVERSITY on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days. The total Approved Budget for the Contract (ABC) of Five Million Pesos Only (PhP 5,000,000.00) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on September 20, 2023 with two (2) prospective bidders in attendance, namely;

- 1. Avescor Motors, Inc.
- 2. F&E Fleet Sales and Services Corporation

WHEREAS, in response to the said posting, there were three (3) prospective bidders purchased the bidding documents, namely;

- 1. Avescor Motors, Inc.
- 2. F&E Fleet Sales and Services Corporation
- 3. A&B United Corporation

WHEREAS, there were three (3) the prospective bidders who submitted their bid proposals within the deadline set on October 3, 2023 at 5pm, namely;

- Avescor Motors, Inc.
- 2. F&E Fleet Sales and Services Corporation
- 3. A&B United Corporation

WHEREAS, during the bid opening held last October 4, 2023, the BAC reviewed the eligibility and technical envelop of each prospective bidders using the pass/fail criteria was used as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

WHEREAS, on October 5, 2023, A & B United Corporation filed a Motion for Reconsideration expressed an apology for using the old form submitted during the opening of bidding documents" and cited "it was purely mistake" wherein they overlooked the attachment;

WHEREAS, after careful deliberation and thorough discussion, the BAC unanimously agreed not to consider the motion for reconsideration of A & B United Corporation;

WHEREAS, on October 17, 2023, financial documents of one (1) bidder were opened and examined, to wit;

WHEREAS, the BAC conducted post-qualification for F&E Fleet Sales and Services (HINO Panay) on November 10, 2023 and November 22, 2023 and has compiled with and is responsive on all requirements and conditions as specified in the Bidding Documents;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that F&E Fleet Sales and Services (HINO Panay), as the Single Calculated and Responsive Bid (SCRB) for the PROCUREMENT OF MINI BUS FOR UNIVERSITY and awarded the contract in the total amount of Three Million Nine Hundred Ninety Thousand Pesos Only (Php 3,990,000.00) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
