# A RESOLUTION DECLARING THESINGLE CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD FOR THE PROCUREMENT OF KITCHEN EQUIPMENT FOR CIT-EPA Project Reference No. ISAT U GOODS 2024-01-005

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for THE PROCUREMENT OF KITCHEN EQUIPMENT FOR CIT-EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) Four Hundred Thousand Pesos Only (PhP 400,000.00) inclusive of applicable taxes, "short of award";
