## A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO WINTERFIELD MARKETING FOR THE PROCUREMENT OF ELECTRICAL SUPPLIES AND MATERIALS Project Reference No. ISAT U GOODS 2025-01-017

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF ELECTRICAL SUPPLIES AND MATERIALS on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Four hundred Thousand Four Hundred Seventy Two Pesos Only (PhP 1,400,472.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on February 12, 2025 with Four (4) prospective bidders in attendance, namely;

- 2. Prime Goods Trading
- 3. Uptown Industrial Sales, Inc.
- 4. Winterfield Marketing

WHEREAS, during the scheduled date for the selling of Bid Documents on February 12-21, 2025 ,Three (3) interested bidders availed the official bidding documents in the amount of Five Thousand Pesos Only (PhP 5,000.00), namely;

- 3. Uptown Industrial Sales, Inc.

WHEREAS, three (3) bidders submitted a bid proposal within the deadline set on February 22, 2025 at 5pm, namely;

WHEREAS, during the bid opening held last February 24, 2025, the BAC reviewed the eligibility, technical and financial envelops of each prospective bidder using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results:
