A RESOLUTION RECOMMENDING AWARD TO JMJ HILADO GLASS AND ALUMINUM SUPPLY FOR THE REPAIR OF STUDENT SERVICES BUILDING GLASS PARTITION WALL THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Office of the Planning Division and Auxiliary Services (PDAS) submitted an Approved Purchase Request No. SVP-2025-013 dated January 23, 2025 with the total Approved Budget for the Contract (ABC) of Two Hundred Forty Two Thousand Six Hundred Seventy Six Pesos and Eighty Eight Pesos Only (PhP 242,676.88) in the Repair of Student Services Building Glass Partition Wall;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

- 2. JMJ Hilado Glass and Aluminum Supply
- 3. Golden Heaven Builders Construction and Supply

WHEREAS, two (2) bidders submitted a quotation within the deadline set on February 7, 2025 at 5pm, namely;

- 1. Giantwest Construction Corporation
- 2. JMJ Hilado Glass and Aluminum Supply

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

 WHEREAS, in the preliminary examination of the bid, the price offer of JMJ Hilado Glass and Aluminum Supply in the amount of Two Hundred Ten Thousand Pesos Only (PhP 210,000.00) was found to be within the ABC and was declared the Lowest Calculated and Responsive quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- To award the contract in the amount of Two Hundred Ten Thousand Pesos Only (PhP 210,000.00) for the Repair of Student Services Building Glass Partition Wall to JMJ Hilado Glass and Aluminum Supply through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
- b. To recommend for approval of the University President the foregoing findings.
