## A RESOLUTION RECOMMENDING AWARD TO AAT FILM PRODUCTIONS FOR THE PROCUREMENT OF ANIMATION THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Public Information and Communication Office (PICO) submitted an Approved Purchase Request No. SVP-2025-006 dated January 16, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Fifty Thousand Pesos Only (PhP 150,000.00) in the Procurement of Animation;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, two (2) bidders submitted a quotation within the deadline set on February 4, 2025 at 5pm, namely;

- 2. AAT Film Productions

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of AAT Fil Productions in the amount of One Hundred Thousand Two Hundred Eighty Eight Pesos Only (PhP 100,288.00) was found to be within the ABC and was declared the Lowest Calculated and Responsive quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of One Hundred Thousand Two Hundred Eighty Eight Pesos Only (PhP 100,288.00) for the Procurement of Animation to AAT Film Productions through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
