A RESOLUTION RECOMMENDING AWARD TO COMPUZEL ENTERPRISES FOR THE PROCUREMENT PVC ID, ID LANYARD AND HOLDER THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Office of the College of Industrial Technology (CIT) submitted an Approved Purchase Request No. SVP-2025-007 dated January 21, 2025 with the total Approved Budget for the Contract (ABC) of Six Hundred Thirty Thousand Pesos Only (PhP 630,000.00) in the Procurement of PVC ID, Id Lanyard and Holder;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, three (3) bidders submitted a quotation within the deadline set on February 4, 2025 at 5pm, namely;

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Compuzel Enterprises in the amount of Two Hundred Seventy Seven Thousand Five Hundred Pesos Only (277,500.00) was found to be within the ABC and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of Two Hundred Sevety Seven Thousand Five Hundred Pesos Only (277,500.00) for the Procurement of PVC ID, Id Lanyard and Holder to Compuzel Enterprises through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
