**A RESOLUTION RECOMMENDING AWARD TO  
DISTRICT 21 HOTEL FOR THE LEASE OF VENUE WITH CATERING SERVICES  
THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT –NEGOTIATED  
PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE )**

WHEREAS, the Office of the Vice President for Research and Extension (VPRE) submitted an Approved Purchase Request No. LV 2025-008 dated March 21, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Fourteen Thousand Pesos Only (PhP 114,000.00) in the Lease of venue with Catering Services ;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of District 21 Hotel in the amount of One Hundred Thirteen Thousand Four Hundred Pesos Only (PhP 113,400.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of One Hundred Thirteen Thousand Four Hundred Pesos Only (PhP 113,400.00) for the Lease of Venue with Catering Services to District 21 Hotel through the Alternative Method of Procurement –Negotiated Procurement (Lease of Real Property and Venue); and
