**A RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO XITRIX COMPUTER CORPORATION FOR THE PROCUREMENT OF IT EQUIPMENT FOR VARIOUS –EPA (LOT 1) Project Reference No. ISAT U GOODS 2025-01-002**

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the PROCUREMENT OF IT EQUIPMENT FOR VARIOUS OFFICES -EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Nine Hundred Thirty Four Thousand Nine Hundred Ninety Nine Pesos and Ninety Six Centavos Only (PhP 1,934,999.96) inclusive of applicable taxes, "short of award";

WHEREAS, a Pre-Bid Conference was held on October 18, 2024 with Six (6) prospective bidders in attendance, namely;

2. Clipdata Computer Center and Sales
3. Computron Business Center
4. Technosure Electronics and Electrical Supply and Services
5. Microgenesis Business Systems
6. Oxord Computer Solutions and Repair Center

WHEREAS, during the scheduled date for the selling of Bid Documents on October 18-28,2024, no interested bidder purchased the official bidding documents in the amount of Five Hundred Pesos (PhP 500.00 ) for Lot 2 while four(4) interested bidders purchased the official bidding documents in the amount of Five Thousand Pesos Only (PhP 5,000.00) for Lot 1, namely;

4. Computron Business Center

WHEREAS, Four (4) bidders submitted a bid proposal within the deadline set on October 29,2024 at 5pm, namely;
