A RESOLUTION DECLARING THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO QUATRO AMIGOS BUILDERS AND SUPPLY FOR THE RELOCATION AND REPIPING OF PLUMBING SYSTEM AT STUDENT SERVICES BUILDING -EPA

WHEREAS, the Iloilo Science and Technology University (ISAT U), through the Bids and Awards Committee (BAC), posted the Invitation to Bid (IB) for the RELOCATION AND RE-PIPING OF PLUMBING SYSTEM AT STUDENT SERVICES BUILDING -EPA on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days with the total Approved Budget for the Contract (ABC) of One Million Twenty One Thousand Seven Hundred Fifty Pesos Only (Php 1,021,750.00) inclusive of applicable taxes;

WHEREAS, a Pre-Bid Conference was held on November 27, 2024 with One (1) prospective bidder in attendance, namely;

1. Quatro Amigos Builders and Supply

WHEREAS, during the scheduled date for the selling of Bid Documents on December 27- December 6, 2024, only One(1) interested bidder availed the official bidding documents in the amount of Five Thousand Pesos Only (Php 5,000.00), namely;

WHEREAS, One (1) bidder submitted a bid proposal within the deadline set on December 7, 2024 at 5pm, namely;

WHEREAS, during the bid opening held last December 9, 2024, the BAC reviewed the eligibility, technical and financial envelopes of each prospective bidder using the "pass/fail" criteria as provided under Section 30 of 2016 Revised Implementing Rules and Regulations of RA 9184, with the following results;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To declare that QUATRO AMIGOS BUILDERS AND SUPPLY as the Single Calculated and Responsive Bid (SCRB) for the RELOCATION AND RE-PIPING OF PLUMBING SYSTEM AT STUDENT SERVICES BUILDING-EPA and awarded the contract in the total amount One Million Eleven Thousand Three Hundred Seventy Nine Pesos and Forty Two Centavos Only (Php 1,011,379.42) inclusive of applicable taxes; and
- b. To recommend for approval of the University President the foregoing findings.
