A RESOLUTION RECOMMENDING AWARD TO DIVERSION 21 HOTEL FOR THE LEASE OF VENUE WITH CATERING SERVICES AND LED WALL RENTAL THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT –NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, the Office of the College of Engineering and Architecture (CEA) submitted an Approved Purchase Request No. LV 2025-007 dated March 8, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Seventy Seven Thousand Pesos Only (PhP 177,000.00) in the Lease of Venue with Catering Services and LED Wall Rental;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, three (3) bidders submitted a quotation within the deadline set on Marc 19, 2025 at 5pm, namely;

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Diversion 21 Hotel in the amount of One Hundred Seventy-Seven Thousand Pesos Only (PhP 177,000.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:
