**A RESOLUTION RECOMMENDING AWARD TO
YSL INDUSTRIAL SALES & MANUFACTURING FOR THE PROCUREMENT OF FOUR
(4) DOOR FREEZER/CHILLER THROUGH THE ALTERNATIVE METHOD OF
PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)**

WHEREAS, the Office of the College of Industrial Technology (CIT) submitted an Approved Purchase Request No. SVP-2025-021 dated February 7, 2025 with the total Approved Budget for the Contract (ABC) of Two Hundred Fifty Thousand Pesos Only (PhP 250,000.00) in the Procurement of Four (4) Door Freezer / Chiller;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, two (2) bidders submitted a quotation within the deadline set on March 5, 2025 at 5pm, namely;

1. YSL Industrial Sales & Mfg.
2. LB2 Laboratory Supplies

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of YSL Industrial Sales & Manufacturing in the amount of Two Hundred Fifty Thousand Pesos Only (250,000.00) was found to be within the ABC and was declared the Single Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of Two Hundred Fifty Thousand Pesos Only (PhP 250,000.00) for the Procurement of Four (4) Door Freezer/Chiller to YSL Industrial Sales & Manufacturing through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
- b. To recommend for approval of the University President the foregoing findings.
