A RESOLUTION RECOMMENDING AWARD TO GOLDEN BAT (FAR EAST) INC, BIOSPECTRA MARKETING AND LIFELINE DIAGNOSTICS SUPPLIES, INC. FOR THE PROCUREMENT OF LABORATORY SUPPLIES AND MATERIALS THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Office of the Research Services Division (RSD) submitted an Approved Purchase Request No. SVP-2025-010 dated January 25, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Three Thousand Seventy Pesos Only (PhP 103,070.00) in the Procurement of Laboratory Supplies and Materials;
