**A RESOLUTION RECOMMENDING AWARD TO
PROGRESS HOME AND OFFICE FURNISHINGS FOR THE SUPPLY AND
INSTALLATION OF WORKSATION AT UNIVERSITY GUIDANCE CENTER
THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED
PROCUREMENT (SMALL VALUE PROCUREMENT)**

WHEREAS, the Office of the Planning Division and Auxiliary Services (PDAS) submitted an Approved Purchase Request No. SVP-2025-031 dated February 21, 2025 with the total Approved Budget for the Contract (ABC) of Five Hundred Eighty Thousand Pesos Only (580,000.00) in the Supply and Installation of Workstation at University Guidance Center;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

1. Progress Home and Office Furnishings
2. Suntawood Home and Office, Inc.
3. SolidGold Multi Resources Corp.

WHEREAS, two (2) bidders submitted a quotation within the deadline set on March 10, 2025 at 5pm, namely;

1. Progress Home and Office Furnishings
2. Suntawood Home and Office, Inc.

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Progress Home and Office Furnishings in the amount of Five Hundred Forty Four Thousand Three Hundred Thirty Six Pesos Only (Php 544,336.00) was found to be within the ABC and was declared the Lowest Calculated and Responsive quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:


- a. To award the contract in the amount of Five Hundred Forty Four Thousand Three Hundred Thirty Six Pesos Only (Php 544,336.00) for the Supply and Installation of Workstation at University Guidance Center to Progress Home and Office Furnishings through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
- b. To recommend for approval of the University President the foregoing findings.
