**A RESOLUTION RECOMMENDING AWARD TO  
OMNIBUS BIO-MEDICAL SYSTEMS, INC. FOR THE PROCUREMENT OF  
BIOMEDICAL FREEZER THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT  
-NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)**

WHEREAS, the Office of the Research Services Division submitted an Approved Purchase Request No. SVP-2025-035 dated February 24, 2025 with the total Approved Budget for the Contract (ABC) of Three Hundred Thirty Thousand Pesos Only (PhP 330,000.00) in the Procurement of Biomedical Freezer;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer Omnibus Bio-Medical Systems, Inc. in the amount of Three Hundred Twenty Three Thousand Pesos Only (323,000.00) was found to be within the ABC and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:
