A RESOLUTION RECOMMENDING AWARD TO BIOSPECTRA MARKETING FOR THE PROCUREMENT OF REAGENT THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Office of the Research Services Disivion (RSD) submitted an Approved Purchase Request No. SVP-2025-011 dated January 24, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Fifty Two Thousand Five Hundred Pesos Only (PhP 152,500.00) in the Procurement of Reagent;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the received quotations were evaluated by the Committee on a 'by line item' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Biospectra Marketing for item no. 4, 6-10 and 11 in the amount of Seventy Two Thousand One Hundred Pesos Only (72,100.00) was found to be within the ABC and was declared the Single Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- To award the contract in the amount Seventy Two Thousand One Hundred Pesos Only (72,100.00) for the Procurement of Reagent to Biospectra Marketing through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
