A RESOLUTION RECOMMENDING AWARD TO CIRCULO HOTEL, INC.FOR THE LEASE OF VENUE WITH CATERING SERVICES THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT –NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, the Intellectual Management Procurement Office (IPMO) submitted an Approved Purchase Request No. LV 2025-009 dated March 27, 2025 with the total Approved Budget for the Contract (ABC) of Eighty Eight Thousand Four Hundred Pesos Only (PhP 88,400.00) in the Lease of Venue with Catering Services and Accommodation;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

- 2. Hotel Vermnica
- 3. Island Hotel

WHEREAS, three (3) bidders submitted a quotation within the deadline set on April 2, 2025 at 5pm, namely;

- 1. Circulo Hotel, Inc,
- 2. Hotel Veronica
- 3. Island Hotel

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Circulo Hotel, Inc. in the amount of Eighty Eight Thousand Four Hundred Pesos Only (PhP 88,400.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of Eighty Eight Thousand Four Hundred Pesos Only Only (PhP 88,400.00) for the Lease of Venue with Catering Services and Accomodation to Circulo Hotel, Inc. through the Alternative Method of Procurement –Negotiated Procurement (Lease of Real Property and Venue); and
