A RESOLUTION RECOMMENDING AWARD TO CIDCLYDE BUILDERS AND CONSTRUCTION SUPPLIES FOR THE IMPROVEMENT OF UNIVERSITY GUIDANCE CENTER THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Office of the Planning Development and Auxilliary Services (PDAS) submitted an Approved Purchase Request No. SVP-2025-033 dated February 27, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Fifty Nine Thousand Pesos Only (PhP 372,796.00) in the Improvement of University Guidance Center;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

- 2. Heaven Builders

WHEREAS, one (1) bidder submitted a quotation within the deadline set on March 10, 2025 at 5pm, namely;
1. Cidclyde Builders and Construction Supplies

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Cidclyde Builders and Construction Supplies in the amount of Three Hundred Seventy Thousand Two Pesos and Fifty Two Centavos Only (370,002.52) was found to be within the ABC and was declared the Single Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of Three hundred Seventy Thousand Two Pesos and Fifty Two Centavos Only (370,002.52) for the Improvement of University Guidance Center to Cidclyde Builders and Construction Supplies through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
- b. To recommend for approval of the University President the foregoing findings.
