A RESOLUTION RECOMMENDING AWARD TO PROGRESS HOME AND OFFICE FURNISHINGS FOR THE PROCUREMENT OF LABORATORY TABLE THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Office of the Research Services Division submitted an Approved Purchase Request No. SVP-2025-037 dated February 24, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos Only (PhP 100,000.00) in the Procurement of Laboratory Table;

WHEREAS, the Bids and Awards Committee (BAC) thru its Secretariat posted the Request for Quotation on the website of the Philippine Government Electronic Procurement System (PhilGEPS), ISAT U Website and at a conspicuous place within the premises of the University continuously for at least seven (7) calendar days.

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

- 1. Maksamiya Medical Supplies and Equipment Trading
- 2. D' Malt Industrial Sales Corp.
- 3. Progress Home and Office Furnishings
- 4. Zeda Technologies, Inc.

WHEREAS, three (3) bidders submitted a quotation within the deadline set on March 11, 2025 at 5pm, namely;

- 1. Maksamiya Medical Supplies and Equipment Trading
- 2. D' Malt Industrial Sales Corp.
- 3. Progress Home and Office Furnishings

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Progress Home and Office Furnishings in the amount of Eighty Seven Thousand Five Hundred Pesos Only (87,500.00) was found to be within the ABC and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of Eighty seven Thousand Five Hundred (87,500.00) for the Procurement of Laboratory Table to Progress Home and Office Furnishings through the Alternative Method of Procurement –Negotiated Procurement (Small Value Procurement); and
