A RESOLUTION RECOMMENDING AWARD TO PREMIER ISLANDS MANAGEMENT FOR THE LEASE OF VENUE WITH CATERING SERVICES THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT – NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, the Office of the Vice President for Academic Affairs (VPAA) submitted an Approved Purchase Request No. LV 2025-011 dated April 15, 2025 with the total Approved Budget for the Contract (ABC) of Two Million Four Hundred Fourteen Thousand Five Hundred Seventy Five Pesos Only (PhP 2,414,575.00) in the Lease of Venue with Catering Services;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

- 1. Diversion 21 Hotel
- 2. SM Prime Holdings Inc- Park Inn By Radisson Hotel
- 3. Premier Islands Management Corporation (Hotel Del Rio)

WHEREAS, three (3) bidders submitted a quotation within the deadline set on May 1, 2025 at 5pm, namely;

- 1. Diversion 21 Hotel
- 2. SM Prime Holdings Inc- Park Inn By Radisson Hotel
- 3. Premier Islands Management Corporation (Hotel Del Rio)

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Premier Islands Management Corporation (Hotel Del Rio) in the amount of Two Million Four Hundred Fourteen Thousand Five Hudred Seventy Five Pesos Only (PhP 2,414,575.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

To award the contract in the amount of Eighty Eight Thousand Four Hundred Pesos Only Only (PhP 2,414,575.00) for the Lease of Venue with Catering Services a to Premier Islands Management Corporation (Hotel del Rio)through the Alternative Method of Procurement –Negotiated Procurement (Lease of Real Property and Venue); and
