**A RESOLUTION RECOMMENDING AWARD TO  
SOL Y MAR FAMILY BEACH RESORT FOR THE LEASE OF VENUE WITH CATERING  
SERVICES AND ACCOMODATION THROUGH THE ALTERNATIVE METHOD OF  
PROCUREMENT –NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND  
VENUE )**

WHEREAS, the Office of the Administration Services Division submitted an Approved Purchase Request No. LV 2025-010 dated April 15, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Five Thousand Pesos Only (PhP 105,000.00) in the Lease of Venue with Catering Services and Accommodation;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

1. Wiljurich Beach Resort
2. Bearland Paradise Resort
3. Sol Y Mar Family Beach Resort

WHEREAS, three (3) bidders submitted a quotation within the deadline set on April 22, 2025 at 5pm, namely;

1. Wiljurich Beach Resort
2. Bearland Paradise Resort
3. Sol Y Mar Family Beach Resort

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Sol Y Mar Family Beach Resort in the amount of One Hundred Five Thousand Pesos Only (PhP 105,000.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

- a. To award the contract in the amount of One Hundred Five Thousand Pesos Only (PhP 105,000.00) for the Lease of Venue with Catering Services and Accommodation to Sol Y Mar Family Beach Resort through the Alternative Method of Procurement –Negotiated Procurement (Lease of Real Property and Venue); and
- b. To recommend for approval of the University President the foregoing findings.


