A RESOLUTION RECOMMENDING AWARD TO DISTRICT 21 HOTEL FOR THE LEASE OF VENUE AND CATERING SERVICES THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT –NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, the Office of the College of Engineering and Architecture (CEA) submitted an Approved Purchase Request No. LV 2025-012 dated May 15, 2025 with the total Approved Budget for the Contract (ABC) of One Hundred Fifty Seven Thousand Five Hundred Pesos Only (PhP 157,500.00) in the Lease of Venue and Catering Services ;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, a quotation was submitted within the deadline set on May 20, 2025, at 5:00 PM, but three (3) bidders submitted their quotations on May 15, 2025, namely:

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of District 21 Hotel in the amount of One Hundred Fifty Seven Thousand Five Hundred Pesos Only (PhP 157,500.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:
