A RESOLUTION RECOMMENDING AWARD TO SMALLVILLE 21 HOTEL FOR THE LEASE OF VENUE WITH CATERING SERVICES THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT –NEGOTIATED PROCUREMENT (LEASE OF REAL PROPERTY AND VENUE)

WHEREAS, the Office of the Vice President for Research and Extension (VPRE) submitted an Approved Purchase Request No. LV 2025-004 dated February 21, 2025 with the total Approved Budget for the Contract (ABC) of Fifty Six Thousand Pesos Only (PhP 56,000.00) in the Lease of Venue with Catering Services;

WHEREAS, the RFQs were issued and duly acknowledged and received by the suppliers, namely;

WHEREAS, the received quotations were evaluated by the Committee on a 'per lot' basis;

WHEREAS, in the preliminary examination of the bid, the price offer of Smallville 21 Hotel in the amount of Fifty Six Thousand Pesos Only (PhP 56,000.00) was found to be within the Approved Budget for the Contract (ABC) with technical specifications deemed compliant based on the Appendix C compliance rating and was declared the Lowest Calculated and Responsive Quotation as indicated in the attached Abstract of Quotation;

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:
