A RESOLUTION RECOMMENDING AWARD TO MEGATEXTS PHIL. INC. FOR THE PROCUREMENT OF E-BOOK THROUGH THE ALTERNATIVE METHOD OF PROCUREMENT -DIRECT CONTRACTING

WHEREAS, the Office of the Vice President for Academic Affairs (VPAA) submitted an Approved Purchase Request No. **DC-2025-020** dated **April 25, 2025** with the total Approved Budget for the Contract (ABC) of **Seven Hundred Fifty Thousand Pesos Only (Php 750,000.00)** in the **Procurement of E-Book**;

WHEREAS, upon evaluation on the submitted request, it was found out that the items needed which is the e-book, only matches to the Wiley Online Books, offering at lower price and no suitable can obtained which is more advantageous to the Government;

WHEREAS, Iloilo Science and Technology University (ISAT U), through its Bids and Awards Committee (BAC) offered **Megatexts Phil. Inc. a sole authorized dealer for the e books of Wiley online Books in the Philippines** to submit the price quotation of the items stipulated in the purchase request;

WHEREAS, a quotation was sent to Megatexts Phil. Inc. on **May 21, 2025**, setting the deadline for submission on **May 27, 2025** at 5:00 PM;

WHEREAS, **Megatexts Phil. Inc.** submitted a quotation on **May 23, 2025**;

WHEREAS, the quotation received was evaluated by the Committee on a "per lot" basis;

WHEREAS, in the preliminary examination of the bid, the price proposal of **Megatexts Phil. Inc.** in the amount of **Seven Hundred Forty Nine Thousand Nine Hundred Eight Pesos Only (Php 749,908.00)** was found to be within the Approved Budget for the Contract (ABC);

NOW, THEREFORE, the foregoing premises considered, WE, the Members of ISAT U Bids and Awards Committee (BAC), hereby RESOLVE, as it is hereby RESOLVED:

1. To award the contract in the amount of **Seven Hundred Forty Nine Thousand Nine Hundred Eight Pesos Only (Php 749,908.00)** for the **Procurement of E-Book** to **Megatexts Phil. Inc.** through the Alternative Method of Procurement -Direct Contracting; and
2. To recommend for approval of the University President the foregoing findings.
